

NOTICE OF REGISTRATION

FOR THE SPECIAL ELECTION TO BE HELD ON TUESDAY, MAY 4, 2021

To the qualified electors of Calhoun County, State of Michigan:

PLEASE TAKE NOTICE that any qualified elector of Calhoun County who is not already registered, may register to vote at the office of their appropriate City or Township Clerk, the Office of the County Clerk, a Secretary of State branch office or other designated state agency; or may use the Online Voter Registration System at www.Michigan.gov/vote. Voters who are already registered may update their registration at www.expressSOS.com.

The last day to register in any manner other than in-person with the local clerk is **MONDAY, APRIL 19, 2021**.

After April 19, 2021 anyone who qualifies as an elector may register to vote in-person with proof of residency (MCL 168.492) at their appropriate Clerk's office at the following times: **(Note: due to the current pandemic, to reduce the spread of COVID-19, and to protect the safety of the public and staff, local government offices may not be open, or be open on a limited basis. It is advisable to contact the office prior to your visit.)**

All offices will be open Election Day from 7:00a until 8:00p.

FIRE PROTECTION AND PUBLIC WORKS MILLAGE

The township is seeking to levy a \$1.50 per \$1,000 property tax for 10 years to fund fire protection services, including dispatch fees, and for the maintenance and operation of township cemeteries, as well as for maintenance and operation of the Graham Lake boat ramp and park operations. The millage would raise an estimated \$226,500 in its first year.
